2. **CONSIDER BOARD ACTION TO APPROVE AND ADOPT AMENDED ORDINANCE NO E-2007**
The board will consider and vote on the approval of the amended Encroachment Ordinance E-2007 that was introduced at the April 30, 2022 meeting.
