Additional work needed on Dunn Road. \$2,000 was approved for Dunn at last meeting but not spent. Additional \$3,300 needed for ditching and remove rock outcroppings in the road.

Chuck Filson met with CalFire, Bill Fullerton of Fire Safe Council and contractors to discuss brushing. Workers can not disturb the soil. Chuck wants to put aside \$5,000 per year so that in 5 years we will have funds to do more brushing.

Nick wants to write a letter to resident property owners about options if not enough board members or participation in the district. Connie pointed out that the nomination papers filing period for the election as a board member is July 15 through August 9, 2024. Papers can be filed at Calaveras County Election Dept.
